

PRIVACY POLICY/TERMS & CONDITIONS

Welcome to Patidarfoods web site. Online Privacy is a constantly evolving landscape and Patidarfoods plans to take all reasonable efforts to maintain up to date and effective online privacy standards and practices. We have linked every page of our web site to this page for your convenience.

General Information

Patidarfoods respects the privacy of our customers, business partners, employees and job applicants, and other visitors to our websites who may choose to provide personal information. We recognize the need for appropriate protections and management of personal information that you provide to us. This Privacy Statement will assist you to understand what types of information we may collect, how that information may be used, and with whom the information may be shared.

Scope

This Privacy Statement applies to Patidarfoods nationwide.

International Users

If you are located outside of the United States, please note that this Site is hosted on our computer servers in the United States. Any personal information collected through this Site may be transferred to the United States and other countries that might not provide an equivalent level of protection as the data protection laws in your home country. Your use of this Site or submission of any personal information will therefore constitute your consent to the transfer of your personal information outside of your home country.

What personal information does Patidarfoods collect?

Personal Information is information that can be used to identify or contact a specific individual, such as a name, address, telephone number or email address. Patidarfoods may collect certain personal information from customers, business partners, employees and candidates for employment. Patidarfoods does not collect personal information when you visit Patidarfoods's web sites unless you choose to provide such personal information. The types of personal information you provide to us on these pages may include name, address, phone number, e-mail address, user IDs and passwords, billing and transaction information, and contact preferences.

How does Patidarfoods use personal information?

Patidarfoods will use personal information to provide customers and business partners with information and services and to help us better understand your needs and interests. Specifically, we use your information to help you complete a transaction or order, to communicate with you, to deliver products/services to you, to bill you for products/services you purchased, and to provide ongoing service and support.

Patidarfoods may share your personal information with third parties in responding to your requests for products or services or product evaluations. Generally, you will be given the opportunity to opt out of having your personal information shared with these third parties. However, if you request information on any of our products/services, Patidarfoods may provide your information to third party distributors and resellers who may subsequently contact you directly for purchase of such products/services. In these instances, you will not have the opportunity to opt out of having your information shared with these third party distributors and resellers.

Patidarfoods also uses personal information to identify and consider candidates for employment opportunities within Patidarfoods. Patidarfoods uses personal information about its employees in connection with the administration of its Human Resources programs and functions and for the purpose of communicating with its employees.

Except as provided in this Statement, Patidarfoods does not use your personal information for a purpose other than the stated purpose for which such information is collected.

Personal information given to Patidarfoods may be transferred within Patidarfoods across state and country borders for efficient data consolidation, storage and simplified information management.

Registration

In order for you to receive certain benefits of our website you may first be requested to provide certain information such as your zip code. Patidarfoods wants to supply you with information that benefits you and the more relevant information we have about you the better we are able to do this.

Patidarfoods currently has an electronic newsletter and may launch similar products in the future. If you choose to receive our electronic newsletter, you will be requested for providing certain information so that we can customize your newsletter to suit your needs. Upon registering for the electronic newsletter, you will be asked for your name, email address, zip code, and other information specified in the enrollment process.

With whom does Patidarfoods share personal information?

Patidarfoods contracts with third party service providers and suppliers to deliver complete products, services and customer solutions. Patidarfoods may share personal information with its service providers and suppliers for the sole purpose and only to the extent needed to support the customers' business needs. Service providers and suppliers are required to keep confidential the personal information received from Patidarfoods and may not use it for any purpose other than as originally intended.

Third party vendors, service providers and suppliers receiving personal information are expected to apply the same level of privacy protection as contained in this Privacy Statement.

Except as provided above, Patidarfoods will not share personal information with any other third parties without your permission. Patidarfoods will not sell, trade, or lease your personal information to others.

Cookies

Patidarfoods may automatically receive and record information on our server logs from your browser, which may include your IP address, Patidarfoods's cookie information, session time, click path analysis, and the pages you request. Patidarfoods will only use this type data in an aggregate form which does not identify you personally.

Choice and Consent

Patidarfoods does not require that customers, business partners or non-employee visitors to Patidarfoods websites provide Patidarfoods with personal information. The decision to provide personal information is voluntary. If you do not wish to provide the personal information requested, however, you may not be able to proceed with the activity or receive the benefit for which the personal information is being requested. Except as expressly stated otherwise in this Privacy Statement, you may opt out of having Patidarfoods share personal information with third parties as described in this Privacy Statement by notifying Patidarfoods in writing of your desire to do so.

Patidarfoods employees and applicants for employment are required to provide Patidarfoods with personal information as a condition of employment, or applying for employment, with Patidarfoods. This information is used by Patidarfoods and may be shared with third party vendors in connection with

Patidarfoods's administration of its Human Resources programs and functions consistent with the terms of this Privacy Statement and applicable law.

Sensitive Information

Sensitive information is defined as personal information specifying medical or health conditions, racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, or information specifying the sex life of the individual.

Except as provided below, Patidarfoods does not request or receive sensitive information from visitors to our web sites. Patidarfoods may receive sensitive information such as medical or health conditions, or race and ethnic data regarding its employees in connection with the administration of its health and welfare benefit plans, or as part of government mandated recordkeeping requirements. Such information will not be shared with third parties without the employee's affirmative approval or as permitted by applicable law. In addition, sensitive information that has not been made public by an affected employee will not be used for a purpose other than its original purpose without the employee's approval unless reasonably necessary for Patidarfoods to meet a legal obligation or to establish a legal claim or defense. Further, Patidarfoods will treat as sensitive any information received from a third party where the third party treats and identifies the information as sensitive.

Access to and Accuracy of Your Information

Patidarfoods strives to keep your personal information accurate. We have implemented technology, management processes and policies to maintain data integrity. We will provide you with access to your information, including making reasonable effort to provide you with online access and the opportunity to change your information. To protect your privacy and security, we will also take reasonable steps to verify your identity before granting access to your data.

Patidarfoods will not process personal information in a way that is incompatible with the purposes for which it has been collected or subsequently authorized by the individual, as required by applicable law.

Security of Personal Information

Patidarfoods is committed to taking reasonable efforts to secure the personal data you choose to provide us. To protect the privacy of any personal information you may have provided, Patidarfoods employs industry-standard controls including physical and logical access controls, Internet firewalls, intrusion detection, anti-virus protection, and network monitoring. In addition, access to sensitive data as defined in this Statement is limited to those individuals and agents having a need to know.

Surveys and Polls
